## Reviewing the new CLSD action plan – 2023-2025:

Judy introduced the work she is doing on a week of CLE in Moree this year. Other legal services who would like to be involved – let Judy know if you are. The idea is to speak informally with community members and groups and listen to concerns and issues that people are facing.

Additional group? Elders group at Shae and Dhiiyaan.

Childrens Court will be sitting in Moree one week a month for 2 days hearing Moree crime and care and protection matters. (Dom)

What is the reason for the increase in number of young people going to court in Moree, is it STMP?

Profiling does occur, STMP is a formal program and does not apply to children. STMP is where regional enforcement squad does proactive surveillance and data i.e., criminal record to put on list of people they keep a close eye on /target even harass. i.e. stop and search with no reason. It has no basis in LEPRA. Whether they use this name or not does not really affect police behaviour i.e. stopping and speaking or even searching people if they have some belief.

## **Fines**

ALS fines clinic is expanding and would love to assist in Moree on ongoing basis. Further discussion to be held between ALS, Revenue NSW and CLSAC about fines activities.

Sean shared how he may be able to contribute to the activities regarding fines in the plan.

Community Connect day will be held in Boggabilla and Mungindi in September.

Toni heard of something at Toomelah and will find out more information in October being organised by Moree Community College – tentative date is 11 October.

**Birth Certificate** clinic for Mungindi (12/12) and Moree (14/12) December. Joint activity between CLSD Regional coordinator and Legal Aid NSW CLSAC.

**NCAT** Indigenous List being created – need to get more information. NCAT no longer come to Moree they only sit in Narrabri. People need to travel or seek permission for AVL. Issue for Aboriginal leadership group at JR in Moree.

Eleanor – NCAT Indigenous List – hope that it can be offered in person, at the moment only. Both parties need to agree to be in the list.

NCAT has sent a letter to Housing Providers, respondents can opt in, but have to go to website <u>Aboriginal Tenancy List (nsw.gov.au)</u> and ask for it. The ALS, Centrelink and Aboriginal tenancy service are available online at the list.

Best advice is for tenants to be referred to a tenancy advocacy service who can then guide them to best outcome: NEWTAAS 1800 836 268 or Northern Aboriginal Tenants Advice and Advocacy Service (NATAAS) 1800 248 913.
