  - C) intentionally or recklessly destroy or damage any property or harm an animal that belongs to or is in the possession of Didier Hasan.

#### Orders about where you cannot go

- 8. You must not go into:
  - A) any place where Didier Hasan lives, or
  - B) any place where he works, or
  - C) any place listed here 321 Pith Street Merrylands NSW 2160.
