I affirm:

1. The document dated 1 November 20XX and signed in the margin by me and by the person before whom this affidavit is sworn is, I believe, the last will of Isabella Rose late of Redfern, nurse, the deceased, and I am not aware of the existence of any other document purporting to embody the testamentary intentions of the deceased.
2. My means of identifying the will are: the deceased was my wife and I have seen her sign her name on many occasions. I recognise the signature on the will as my wife's signature.
3. The attesting witnesses to the will are Jack Smith and Jill Smith.
4. The deceased died on 20 June 20XX, aged 64 years, and I believe that the deceased is Isabella Rose referred to in the certificate of registration of death which is annexed and marked "A".
5. The deceased did not marry after the will was made.
