

Care and Protection Representing Children



Overview

The Care and Protection: Representing Children training module aims to private lawyers with an overview of the responsibilities of independent and direct legal representative in care proceedings, information on meeting with children, and explains the social science and legal issues that are relevant to child representatives. This training module will provide new child representatives with knowledge of the role and their obligations as a child representative. It covers a range of topics that identify legal issues and practical skills specific to the child representative.

Learning Outcomes

By completing this training module, participants will:

- understand the role of the child representative including the legislative framework and the expectations of the bench in fulfilling this role
- 2. have more confidence and skills in meeting with and interviewing with children
- 3. have knowledge of how to work collaboratively with the Department of Communities and Justice
- 4. proactively represent children in Dispute Resolution Conferences
- 5. proficiently draft legal documents and make succinct but thorough submissions to the Court
- 6. assist with the development and amendment of care plans and leaving care plans
- 7. understand and ensure the appropriate representation of Aboriginal and Torres Strait Islander children
- 8. draft orders and applications and make submissions in relation to clinic and expert reports
