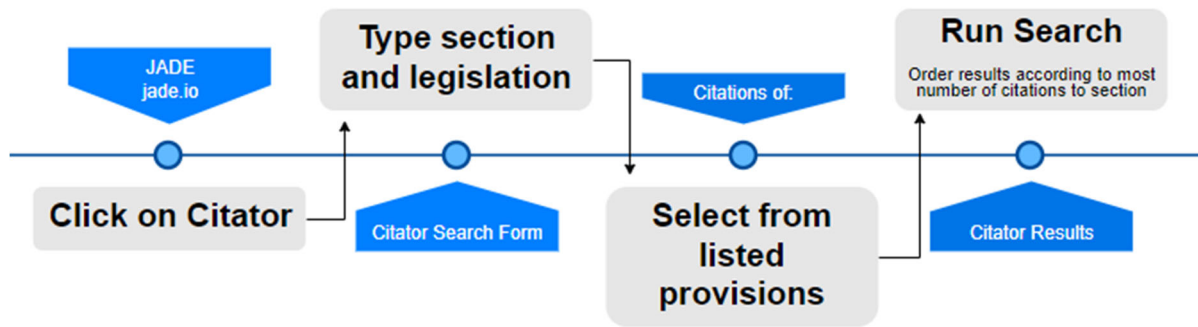
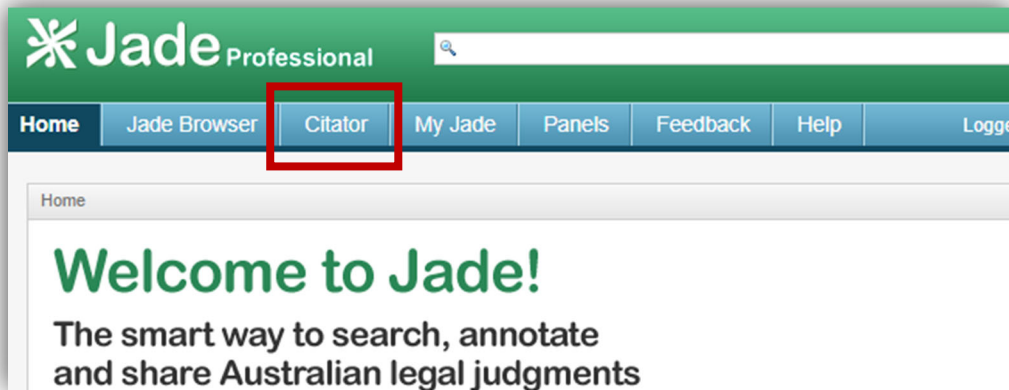


Locating References to Legislation – JADE



Example: Locate cases that judicially considered section 22(1)(a) of the (NSW) Bail Act 2013 (or section 30AA (NSW) Bail Act 1978).

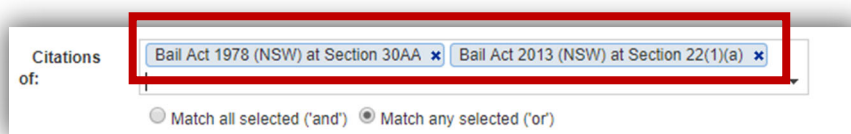
Step 1. Click on **Citator**



Step 2. In the field **Citations of** type **s22(1)(a) Bail act**, then select from the listed suggestions



►► The section of interest should now appear as a tile.



Step 3. In the field below, type **“special or exceptional circumstances”**, then run the search
