


Population count by postcode


First Nations population count by postcode




Index of relative socioeconomic disadvantage (SEIFA) by postcode










Breach ADVOs comparison against (none selected) by LGA








Domestic violence related assault comparison against (none selected) by LGA



DV Intimidation, stalking & harassment comparison against (none selected) by LGA









Bail status at First Court Appearance for 10-17 Year Olds Charged by Police Jan – Dec 2023










