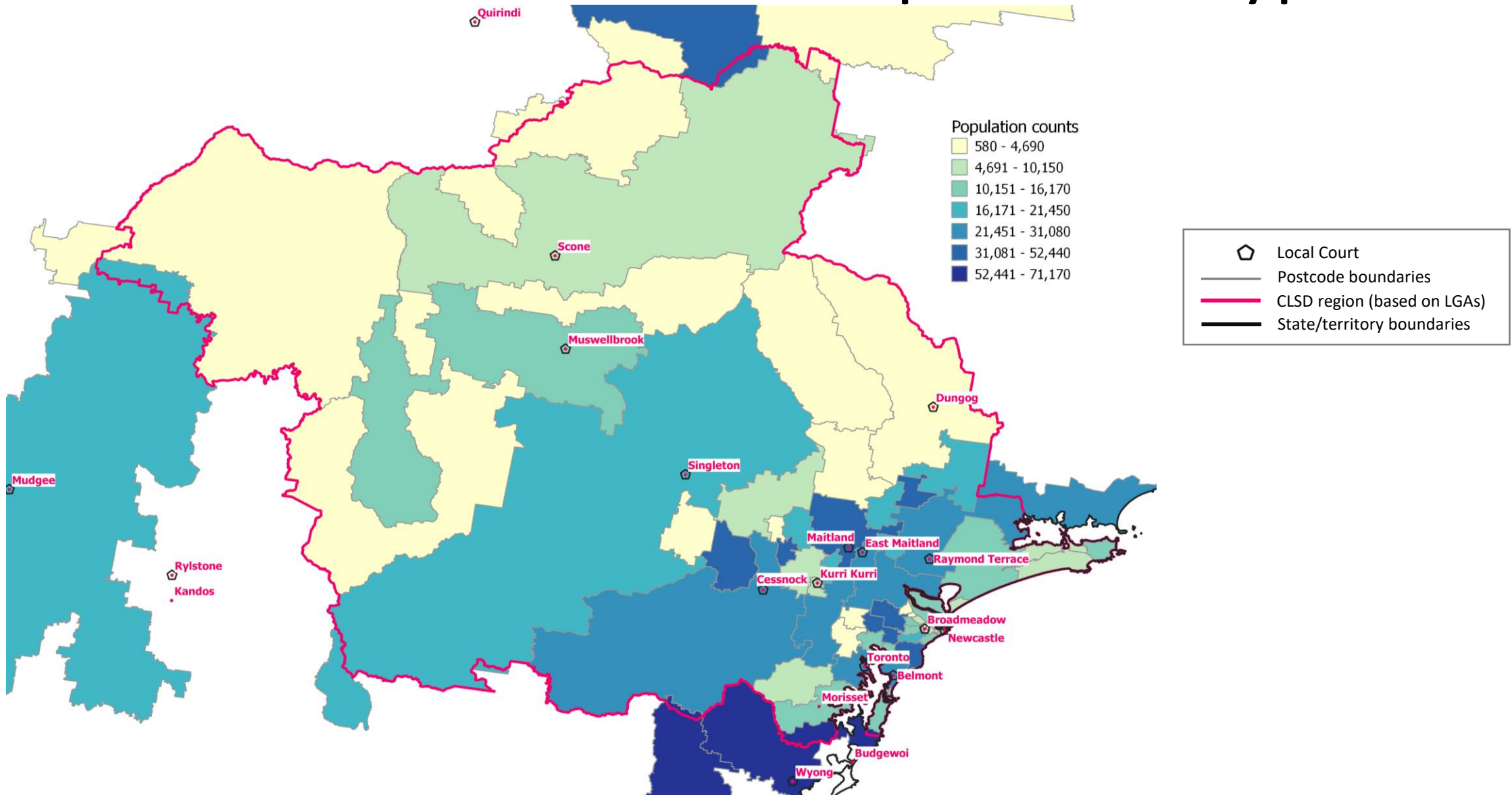

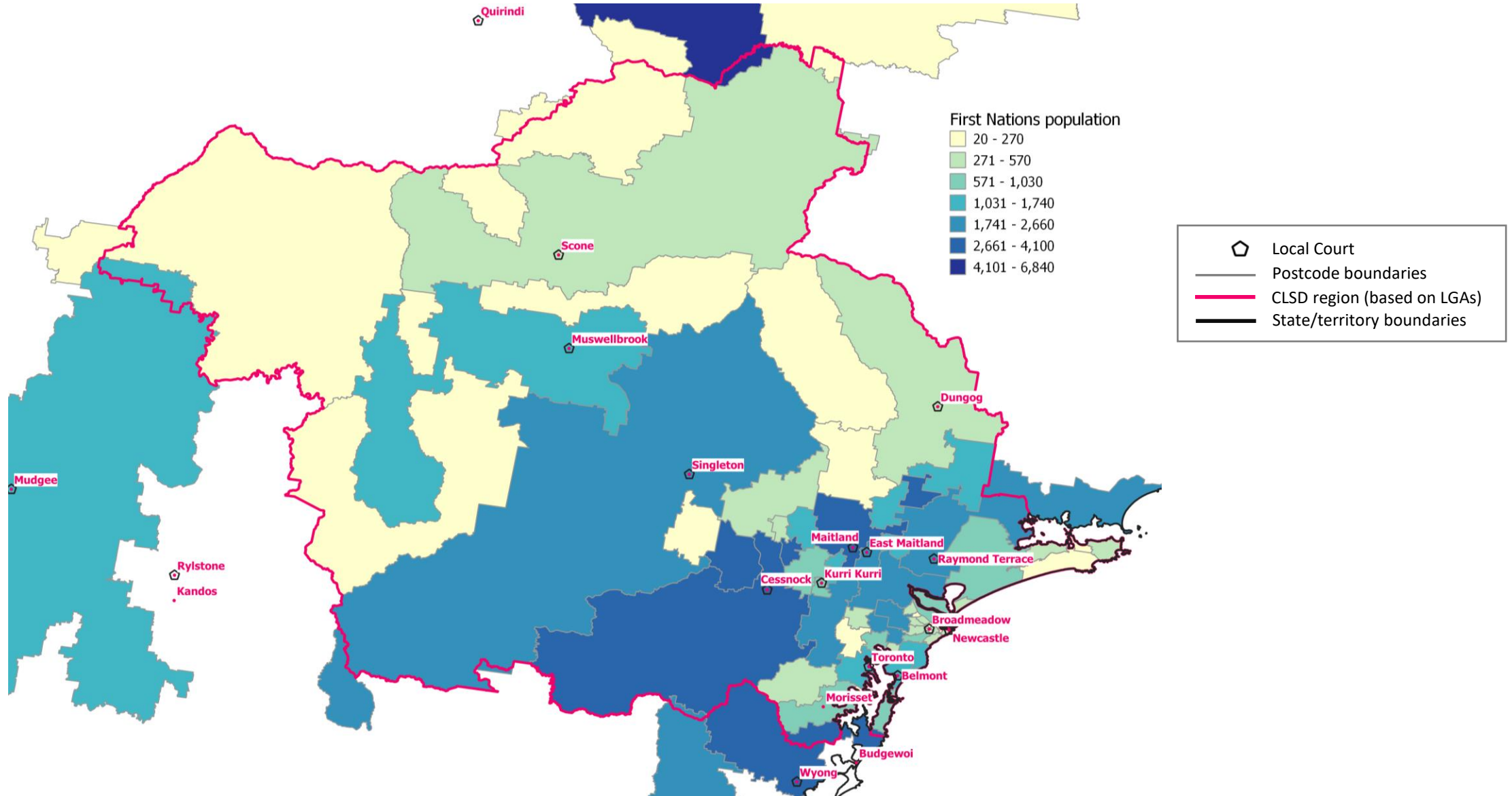
# Population count by postcode

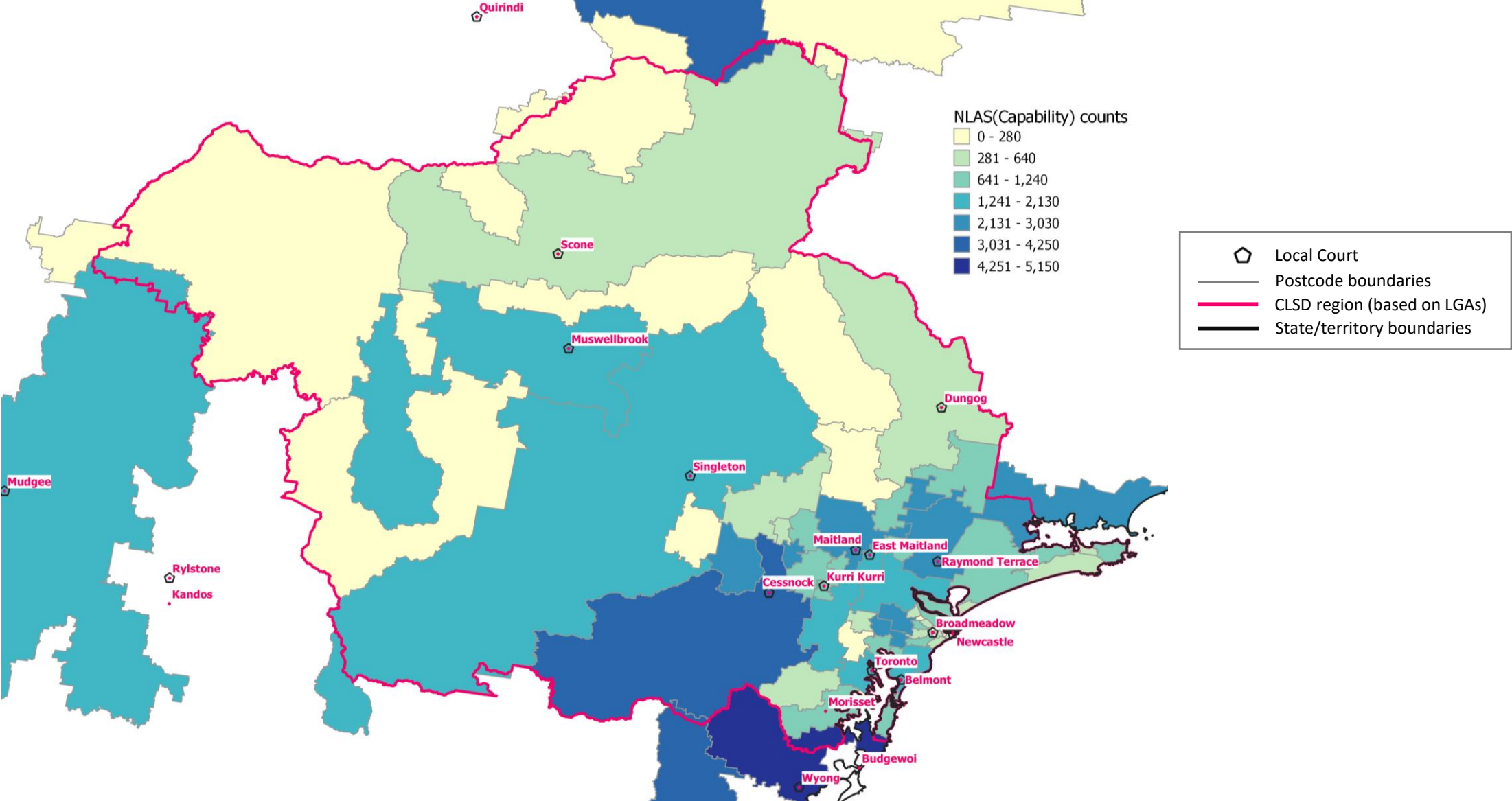
# First Nations population count by postcode

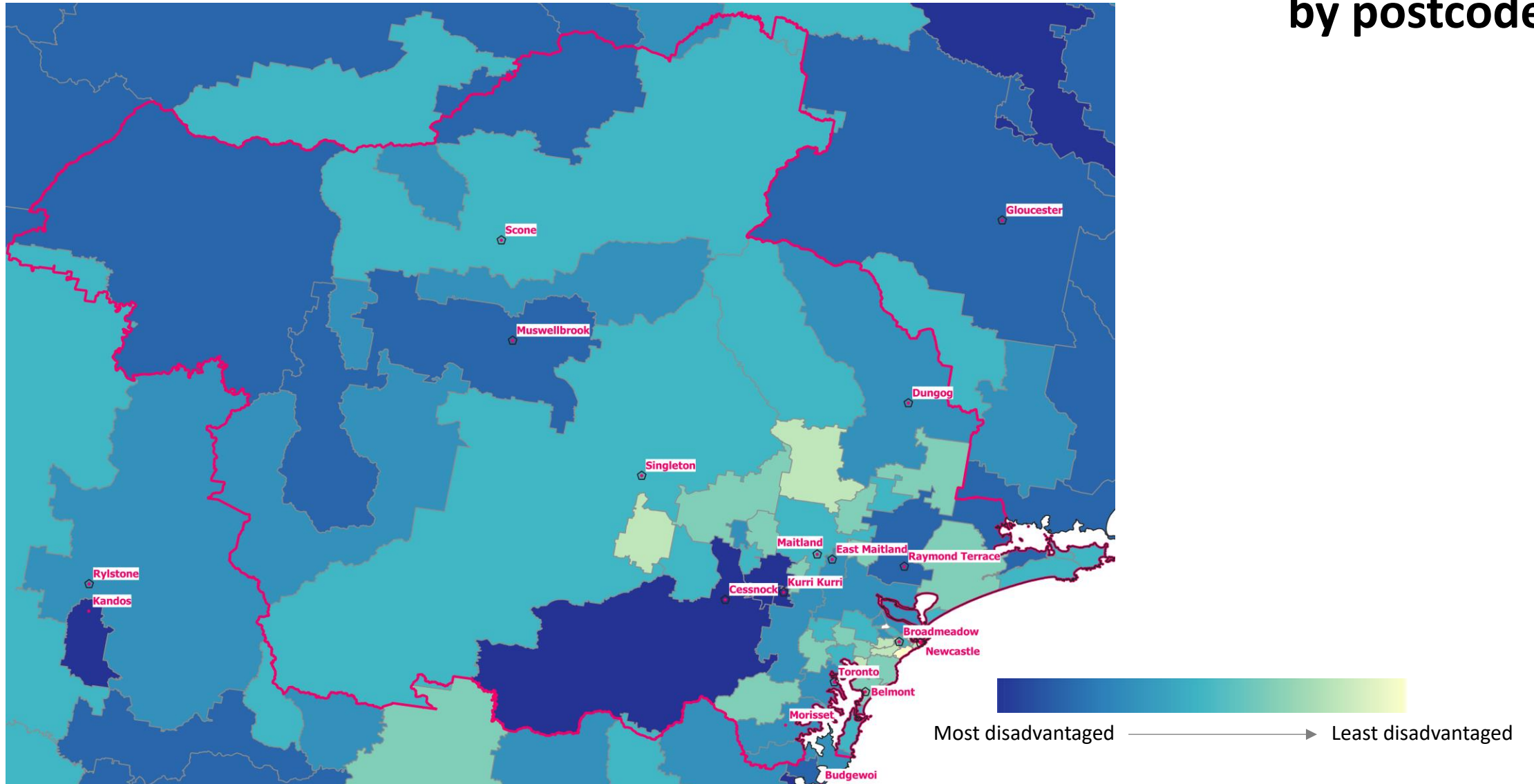

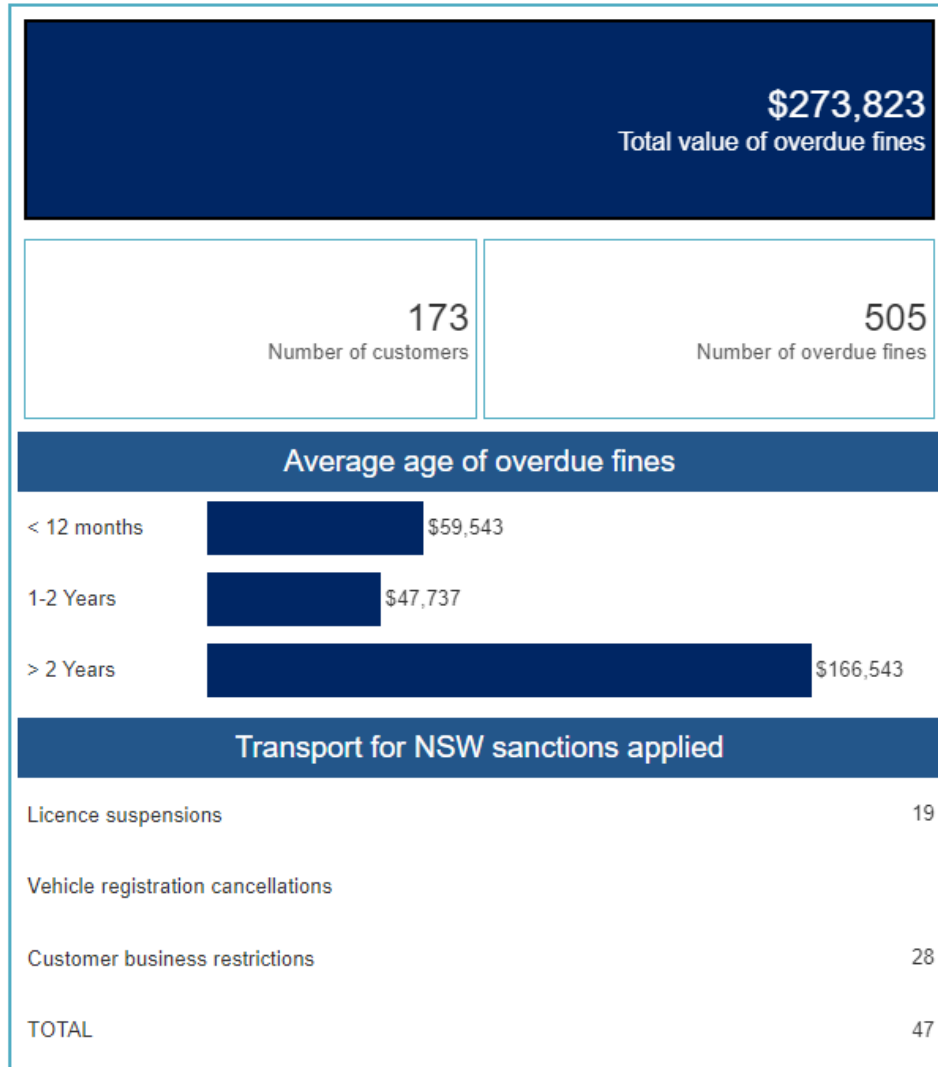

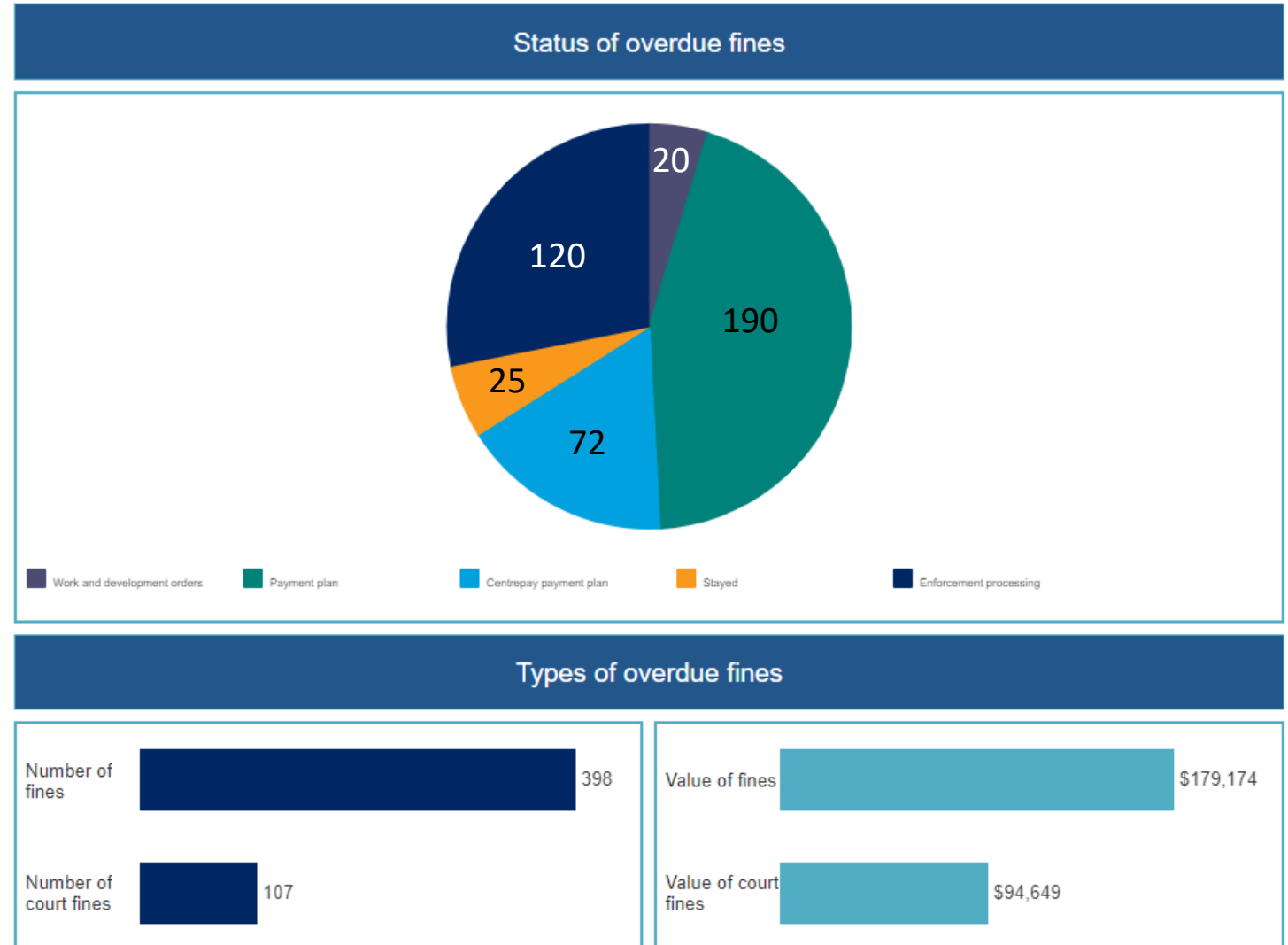

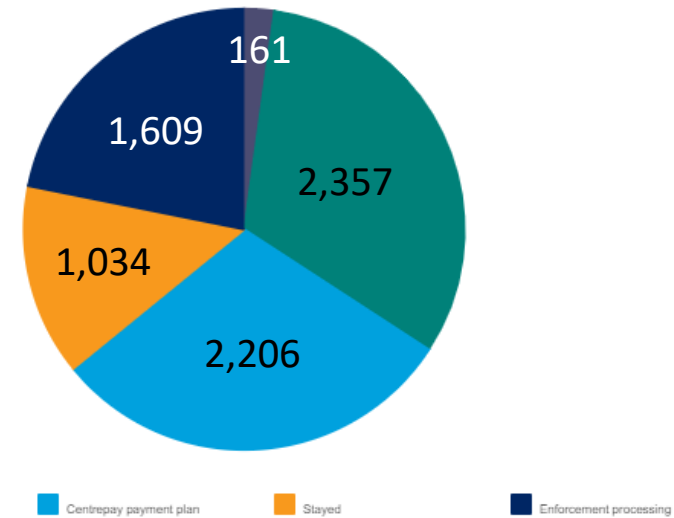
