#### Torts - Negligence - Motor Vehicle Accident - Write Off

A claim for money to recover the value of your vehicle and other related expenses where your vehicle has been 'written off' and where the defendant is the driver of the vehicle that you claimed caused the accident. Use this Type of Claim if you are claiming against another driver for the market value of your car, if your car is written off. If you are making this type of claim, you should get legal advice.

### Torts - Negligence - Motor Vehicle Accident - Vicarious Liability

A claim for money to repair damage to your vehicle and other related expenses resulting from a motor vehicle accident where the defendant was not the driver of the vehicle causing the accident. For example, where the other driver is the employee of the owner of the vehicle. Use this Type of Claim if you are claiming against the owner, not the driver, of the other vehicle for the cost of repairs to your car. If you are making this type of claim, you should get legal advice.

#### PLEADINGS AND PARTICULARS

In this section you need to write a clear description of your claim in numbered paragraphs. You should refer to yourself as the plaintiff, and the other party as the defendant. You need to include:

- 1 the details of your car including make, model and registration number
- 2 the details of the defendant's car including the make, model and registration number
- 3 the date, time and place where the accident happened
- 4 the details about how the accident happened
- 5 a brief explanation of why the other driver was negligent. To do this you can write a bold heading called "**Particulars of Negligence**" and then list the reasons why the other driver was negligent. For examples of Particulars of Negligence, see <u>Sample statement of claim – car accidents</u> and <u>Example</u> <u>pleadings and particulars – car accidents</u>. It is important that you provide the particulars (details)) of the other driver's negligence so that the court and the other driver know why you think the accident was the other driver's fault. You need to make sure that the particulars of negligence are relevant to the circumstances of the accident.

- 6 a description of the damage caused by the other driver to your car and/or to any other property that was in your car at the time of the accident
- 7 the costs of the repairs to your car, or an estimate of the costs to repair your car. You can write a bold heading called "Particulars of Damage" and then list the costs of repairing each part of your car that was damaged in the accident. For an example of Particulars of Damage, see <u>Sample Statement of Claim car accidents</u>.
- 8 The total amount of your claim.
  - Claiming the costs of completed repairs
    If you are claiming for the costs of repairs to your car that you have already had done, you can include a paragraph that says something like:
    *"The plaintiff claims the sum of \$xxxx.xx being the actual costs incurred by the plaintiff in repairing the plaintiff's motor vehicle."*
  - Claiming the costs of repairs to be done
    If you are claiming for the costs of repairs to your car on the basis of a quote, but you haven't had the repairs done yet, you can include a paragraph that says something like:
    *"The plaintiff claims the sum of \$xxxx.xx being the estimated costs of repairing the plaintiff's motor vehicle."*
  - Claiming the costs of a write-off
     If you are claiming for the replacement cost of your car after it has been written off, you can
     include a paragraph that says something like this:
     *"The plaintiff claims the sum of \$xxxx.xx being the market value of the plaintiff's motor vehicle
     before the accident less the salvage value of the plaintiff's motor vehicle after the accident."*

The salvage value means the amount that you would be able to get if you were able to sell the damaged car as is, for example for scrap metal and/or parts.

• whether you are claiming interest and how the interest is calculated. You can only claim interest if your claim is more than \$1,000.

You should make sure you give proper particulars of your claim. If you don't, the defendant can ask for 'further and better particulars', which will mean that your claim might be delayed. If this happens, you may have to pay the legal costs of the defendant. If the pre-trial review date is 'adjourned' (put off to another date) because you have not given proper particulars, you might be ordered to pay some of the legal costs of the defendant.

  - Paying the plaintiff that part of the money that is claimed.
  - Filing a defence in relation to the part that you do not believe is owed.
